Your bequest may be made in any of the following ways:

- A gift of a fixed asset or stated sum of money as designated in your Will.
- A gift of a specific or designated item in your Will, for example; shares, real estate, art, jewellery, artefacts, memorabilia or other items of value.
- A gift of all or a portion of the remainder of assets after all other bequests have been made and debts and taxes paid.
- A gift made on condition of a certain event that may or may not happen. This is quite specific and fails if the condition is not met.
- A bequest is yours to make, you may dictate the conditions and bequests don't have to be binding – if you change your mind or your circumstances change in the future then simply call us.
- Formalising a bequest usually involves a simple addition or codicil to an existing Will or your wishes can be written into a new Will – a Statement of Intent would normally be held by the School.

Donations and bequests are tax deductible.
